- iii. Integrity Certificate/Vigilance clearance in respect of the officer; and
- iv. Cadre clearance in respect of the officer.

3. All other terms and conditions for filling the posts of Joint Mission Director (Research & Innovation) and/or Deputy Mission Director on deputation basis will remain same as mentioned in this Ministry O.M. dated 21.05.2026 (Copy enclosed).

4.
